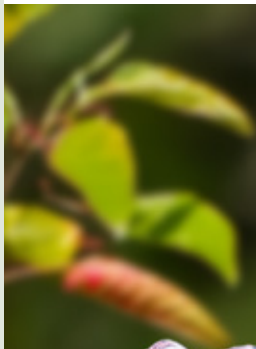

Years before ground was broken on Greater Baltimore Medical Center in 1962, volunteer board members of our two founding hospitals – The Hospital for the Women of Maryland, of Baltimore City and the Presbyterian Eye, Ear, and Throat Charity Hospital – began knocking on doors. They asked their neighbors if they would support the creation of a hospital to serve the area of Baltimore County just north of the city. The answer was a resounding “yes,” and they were met with an overwhelming groundswell of support. Those volunteers eventually became the GBMC Volunteer Auxiliary, which, in November, celebrated 60 years of service and an incredible 3 million hours volunteered.

Thank you to our dedicated GBMC volunteers for giving us our start and for your decades of support that have carried us through to this day.

SANDRA R. BERMAN PAVILION CONSTRUCTION IS ON TRACK FOR A *2025 Opening*

Construction of the Sandra R. Berman Pavilion is well underway. This new home for cancer care at GBMC will open in the spring of 2025.

The four-story Berman Garage, beneath the new Sandra R. Berman Pavilion, provides easy access for cancer patients and their families to all oncology services, including the Sheila K. Riggs Radiation Oncology Department. An enclosed walkway connects it to the new Louis and Phyllis Friedman Building.

Pediatric UPDATE

After a much-needed summer reprieve, filled with typical children's ailments like insect bites and playground injuries, autumn brought an uptick in patient volumes. Consistent with what all children's units see across the country, RSV, flu, and COVID were in full swing, with increased rhinovirus and enterovirus, making asthmatic children sicker and more likely to need hospitalization.

Thanks to our generous community, particularly the Nora Roberts Foundation, which made a lead gift to a special Pediatric Emergency Campaign, we were ready for the sharp increase in cases in 2023. Additionally, The Ruth Carol Fund, longtime supporters of GBMC, made a transformational gift to create a Pediatric Endowment Fund, which will support the department for years to come.

We invested Emergency Campaign contributions in new protocols specific to the escalation of respiratory care in children and also updated our equipment. We are fully staffed with nurses for increased volumes, and we've brought another full-time Emergency Department pediatrician on board, which will allow for increased double physician coverage. Our most critical life-saving improvement has been the addition of a helipad on campus. Previously, we relied on a nearby school's field for Medevac helicopters to land and transport critically ill pediatric patients who require higher-acuity care. The new helipad saves time and an additional ambulance ride.

In two to five years' time, we aim to fully renovate our Pediatric Inpatient and Emergency Department unit, which will increase its capacity, as well as add a serene and beautiful waiting room just for children.

These are still trying times for healthcare as we continue to rebuild from the pandemic: the supply chain is delayed, and we are paying a premium for medications crucial to the care of children, including liquid antibiotics and steroids. It is only because of your generosity that we can provide pediatric specialty care to our community 24 hours a day, 7 days a week, 365 days a year. GBMC is the only fully dedicated Pediatric Emergency Department in Baltimore County; thank you for making it your philanthropic priority.

ADVANCEMENTS IN *Surgery*

This year, with lead gifts from The Kahlert Foundation and the Presbyterian Board of Governors, GBMC is improving access to minimally invasive surgical care with the purchase of an additional daVinci surgical robot.

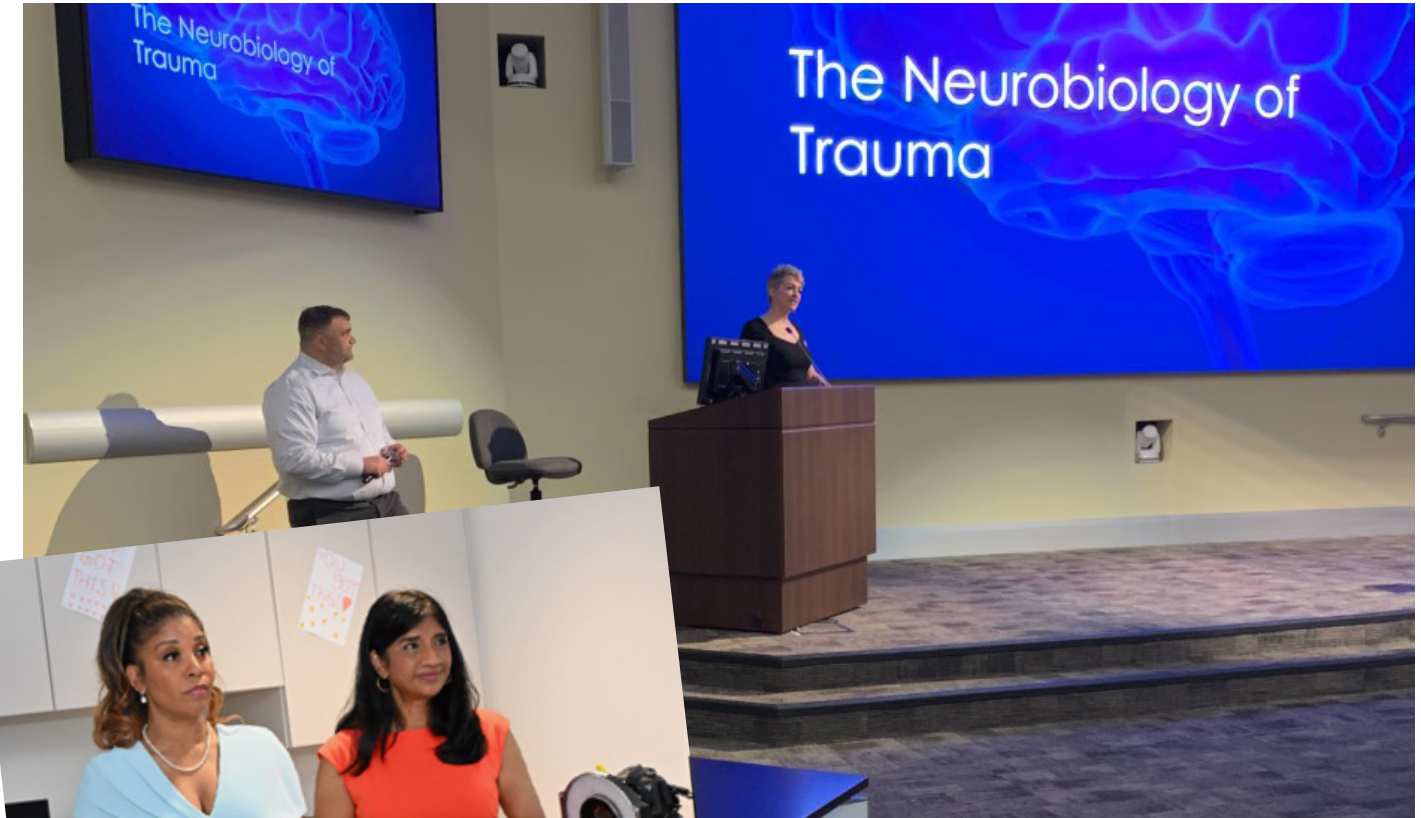
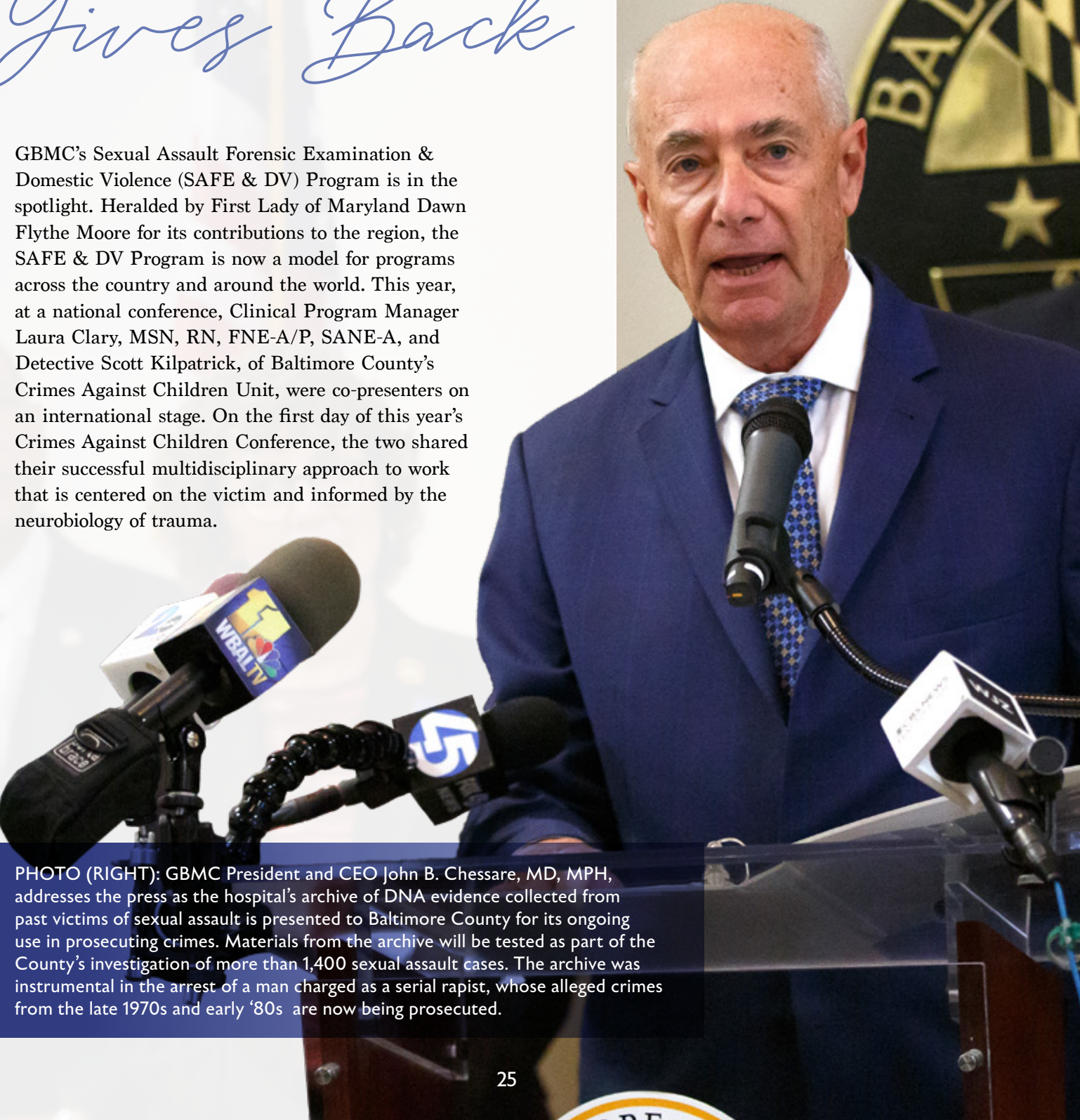

SAFE & DV PROGRAM Gives Back

GBMC's Sexual Assault Forensic Examination & Domestic Violence (SAFE & DV) Program is in the spotlight. Heralded by First Lady of Maryland Dawn Flythe Moore for its contributions to the region, the SAFE & DV Program is now a model for programs across the country and around the world. This year, at a national conference, Clinical Program Manager Laura Clary, MSN, RN, FNE-A/P, SANE-A, and Detective Scott Kilpatrick, of Baltimore County's Crimes Against Children Unit, were co-presenters on an international stage. On the first day of this year's Crimes Against Children Conference, the two shared their successful multidisciplinary approach to work that is centered on the victim and informed by the neurobiology of trauma.
